NFAA Directors Report: In a packet that was handed out. (Clubs not in attendants will receive in an email.) The chart with Clubs expiration dates of their NFAA Charter also the expiration of the Club's ranges inspection. Lunenburg's and Pequig have been inspected. Bay Path needs their ranges inspected by August 2, 2020. Granby and Riverside, Woburn will need to be inspected by October of this year. Pequig will be sent an email to remind that the clubs charter needs to be renewed by July 18, 2020. The Documentation for the range inspection there is now all computerized in PDF format and will be filled out and sent to NFAA online. The director has contacted NFAA, it has been okayed for the digital signature. So, if the club can print out the forms and when the director is doing the inspection, he may take notes on them. But will fill out the forms online and send them in to the NFAA by online and the club will get a copy of the report via email in PDF format.

No notification from the NFAA about any for the future Tournaments due to Covid-19. The Target Championships that are held in Yankton, SD in late August early September maybe still a go.

NESFAA Championships that is held Labor Day Weekend. It still scheduled to go on and the format will be the same original format. The new test format will not be in use.

Westfield did not renew the clubs Charter. Warren Sweat let President know by email that the Westfield was not renewing their charter this year, that it will be re-evaluated next year.

S.A.A.M has decided this year that there will not be any Outdoor Championships FITA tournaments this year. Bay State Game Canceled, State Outdoor Championships canceled.

Now there is an open date July 19, 2020. Email will be sent out to the clubs for the opportunity to take the shoot.

Old Business: No Report

New Business: The discussion of the missed points not received due to canceled of Sunday shoots because of the Pandemic. Five indoor Shoots and Four outdoor field shoots. The Points for the end on the year awards. There were things discussed about giving a lump sum of points, but since the number of shooters is undetermined, that maybe just rewarding the shooters that have been attending recent shoots extra points. Argument was made that the director would review the attendants of the 2018-2019-year shoots of the shooters attending and reward those shooters. But on the other hand, that the archeries are not paying to attend shoots, so the points are not there. That giving away points not paid for should not be a practice. Several MFAA shooters where asked how they felt, and they had no opinion on the matter. But the Dedicated Sunday Shooters that are out at every Sunday shoots. Archers understand that the pandemic canceling everything, that 2020 is a very unpredictable year. It was the governor that put the sanctions into place not MFAA not the archery clubs to not reward points should be understood. A decision was made and voted on by the board. Proposal was made by David F. "Not to reward points for any of the canceled indoor or outdoor field shoots due to the Pandemic." David S. first the motion and Annette F. Seconded, Motion carried.

No Points will be awarded for cancelled shoots.

MFAA States Indoor Championship are still going to happen. Bay Path is hosting November 8, 2020 three lines and if needed with an overflow date will be November 7,2020.

Bay Path needs to give back their scheduled August 16 shoot due to the club scheduled another event. The director will send an email to the clubs to offer the open date.

Bay Path is having the MFAA State Outdoor Championship are on August 2, 2020 starts at 9 am and awards will be presented. The registration form will be on the website. Minimum of three shooters in a group. Began a discussion of the definition of the cost of a family to shoot. So, to determine how many is in a family. Should it be two parents and one child with additional child free. A proposal will be written up and when the by-law committee is present as soon as the annual meeting it will be voted on.

Good of the Association: Next meeting a Nomination committee will need to be assembled for the NFAA Director and MFAA President positions will be up for re-election along with the two board members.
