New Business:

 Nomination committee needs to be formed for the February 2019 elections for President, 1st Vice President, and NFAA Director.

David Ferrie is going to put his name in for NFAA Director, will also go for re-election for MFAA President; Pat Tuttle will go up for re-election for 1st Vice President. Nomination close in December. Carmen Salver was nominated for MFAA President by David Ferrie.

- Youth Committee: David Ferrie is heading the committee, has been trying to get a hold of Natalie Vollmer of the NFFA office for the pricing of the awards. The mission is the get the Youth League award program started by the beginning of the 2018-2019 Indoor season. By the October meeting there will be something in place on "What the MFAA Youth League Award Program" is all about.
- 3. Scholarship Committee: Carmen Salver has set up a draft for a Scholarship application. That the application would be finalized and on the MFAA website for applicants to have for the beginning of the January semester. It will be a \$500 scholarship awarded to one female and one male with evidence of acceptance and intent of attending college. That the scholarship doesn't renew yearly. Students must reapply each year with a new application. Motion made to make changes to "award the scholarship to the candidate, post-secondary education acceptance is required" Lunenburg made the motion and it was 2nd by Ed Woodcome
- 4. MFAA Grant Committee: Need to create a criterion for the MFAA Grant for MFAA Clubs to request MFAA grant money. How many MFAA grants will be given out per year? Should the MFAA grant be capped on its amount? When will the next time an MFAA club that has been gifted the MFAA grant be allowed to reapply. President hopes that it will be possible for each MFFA clubs to have the opportunity to apply for the MFAA grant. So that would be a nine-year rotation Carmen Sarver nominated to Head up the MFAA Grant Committee by Pequoig and 2nd by Lunenburg
- 5. Voting on Bay Paths Archers request for MFAA Grant money: Referring to the May Meeting minute "that it is up to the Clubs to put together a Proposal for what their planning on using the money for. Should submit a proposal for the MFAA Board to vote on it." President declares that at this time as far as request criteria Bay Path Archers has presented the proper criteria for their Proposal following the May Meeting minutes. The Board would make a motion on to awarded Bay Path Archers. Motion was made by Pat Tuttle to awarded Bay Path Archers a MFAA Grant of \$600.00 and was 2nd by Rob Randle.

6. Charter renewal reminders: South Hadley and Woburn needs to take care of their club charter with the NFAA before the October meeting or won't be able to choose shooting dates.
